Costs- reservations:

A reservation is confirmed and final after payment. Payment must be made within 5 days after invoice. We have a non-refundable cancelation policy. Tenant receives an instruction manual which will be further explained by the landlord.

All prices are exclusive VAT. VAT is applicable to companies outside of The Netherlands. Amounts are subject to all rights. Landlord has the right to adjust the amounts.

Tenant owes a deposit of minimal € 500. Damage, beverage, theft, the calculation of supplemental work, cost savings, the violation of the General Conditions and / or Manual and all extra costs such will be settled on the deposit within 2 weeks. The crane must be cleaned by tenant before check out time. If, in the opinion of Faralda, the crane is still dirty, € 200 will be charged form the deposit.

Security/ staff:

Unless otherwise determined, Landlord delivers a studio manager and bar staff. All instructions from the staff must be followed immediately.

Guests may only access the crane when they are listed on the Guest list. Therefor tenant has to deliver Landlord anytime an accurately guest list with all names, contact details of the guests who entre the crane.

Door host or security at the entrance of the crane provided by tenant welcomes and checks the guests of tenant. Security takes place in the opinion of Faralda. Security costs will be charged to the tenant.

Safety - Monumental:

Faralda Crane Hotel is a monumental building. Adjustments in, and on the Crane are not allowed. Despite the safety devices the Crane meets the highest demands. Entering the Crane is entirely at your own risk.
