## 7. General Conditions & Manual

The crane is a private venue. Access on request; Private - Invites only. A booking is final after approval, and allocation. Faralda is a listed heritage building. It's a crane. To prevent damage and because of safety, we have regulations. Faralda apply our "Conditions & Manual". Please ask if you want us to explain the "Conditions & Manual" on request.

Host is understood to mean the person who organizes the event, the person or entity who has agreed to these Terms and Conditions and Manual or the person or entity paid the invoice.

Guest is everybody, instead of staff, landlord, who has agreed to these Terms and Conditions and Manual. Guests must behave in accordance the law, regulations and everything that is stipulated in the Conditions & manual.

Prices are subject to change; Excluding additional costs, deposit, TAX & F&B; We apply our General conditions  
Entering Faralda Crane Hotel is at your own risk. Faralda does not accept any liability for damage because of requests from the police, municipality, nuisance, fire, vandalism, terror, technical failures, weather influences resulting in early closure. Faralda is not liable for any damage, injury, loss / theft. Instructions from staff must be followed without delay.

Hosts must submit a guest list for the event. The maximum number of guests in the studio is 71 people. This includes all attendees. Because of safety, (technical) restrictions or weather conditions, access to Faralda is sometimes impossible. Instructions from staff must be always followed. Faralda always has the right to deny persons access to the crane and to terminate or cancel events. NDSM is a festival area. Faralda therefore accepts no liability for events, (noise) nuisance.

Timetable for events in the studio:

- Doors open: 21.00
- Music off before: 04.45
- Studio empty: before 05.00

Additional costs will be charged if host wishes to start an event earlier. Names of guests must be provided 2 days in advance. Faralda has the right to deny access at all times. Subject to written permission from Faralda, it is not allowed to bring own drinks, refreshments or food in the crane. Drinks can be purchased at the bar. Cups must be placed in the special cup holders. No own drinks, no drugs, no weapons, no glassware outside, no nuisance to other guests or neighbors / environment.

Commercial events are only allowed with written permission from Faralda. Without written permission from Faralda it is forbidden to record, take or produce any kind of sound and image, presence of sound or bring own photo or recording equipment.

In the interior of the studio flyers and poster with a maximum diameter of 60 cm is allowed under condition that the host names #faraldacranehotel and #cranesessions are recognizable in communication / publications / final editing.

If the tenant does not comply with this rule, an immediately payable compensation of at least € 1500 will be charged.

This amount may ultimately be increased by other costs and damages.

Host is responsible for all damage. Damage in the opinion of Faralda must be recovered without any notice of default. Host pays a deposit of € 750 upfront the event. The deposit will be settled with damage and consumptions.

Due to availability from other organizations, the Faralda studio and suite(s) must be delivered as it was found.

Entering Faralda Crane Hotel is at your own risk. Faralda is not liable for any damage, injury, loss / theft. In the event of violation of these Conditions & Manual, hosts (or if known violators) are liable for every kind of damages. If, in Faralda's opinion, the provisions in the Manual and General Terms and Conditions are not observed, all costs (including for repair) have to be paid by host without any notice of default.

The 5 star Faralda Secret suite on top of the crane is available for back stage. Capacity is 18 VIP max.

Extra or excessive amounts of drinks (at the discretion of Faralda) will be refused and/or charged extra costs will be charged.

Because of safety, the door policy is strict. Max. the capacity of 80 pax. We apply a wristband, provided by Faralda. If the host allows more than the maximum number of guests, the event can be canceled by Faralda for safety reasons. Faralda cannot be held liable in any way. Faralda reserves the right to compensation.

**Safety & Damage:**

- Use the emergency stairs in the tower except in case of emergency
- Smoke (there are signed smoking areas)
- It is strictly forbidden to enter areas marked with "NO ENTRY" signs.
- Without permission of Faralda it is forbidden to stay with more than 2 people in your suite.
- Smoking is not permitted except at designated locations
- Only use toilet paper. No trash or cleaning tissues.
- It is strictly forbidden to use confetti or any other material resulting in additional cleaning costs.

In case of non-compliance costs of these conditions an immediately amount with a minimum of € 450 costs will be demand. If, in the opinion of Faralda, extra cleaning needs to be done, additional costs will be charged.

**\*Use of Stairs, suites & Elevator:**

In case of an event, access to Elevator 2 (to one of the suites) is only allowed under the supervision of Faralda. To prevent excessive wear and noise, the use of the lifts is limited to a maximum of 4 lift movements per hour. 1 lift movements is up or down. More than 4 trips per hour calculate € 5 per trip. Cost for staff on request.

- Maximum capacity Elevator 1: 800 kg – or 8 persons
- Maximum capacity Elevator 2: 300 kg – or 3 persons

Without written approval of Faralda it is not allowed to use Elevator 1 during events.

- Red spiral staircase: Ground floor/Entrance to Studio & Platform 2
- Elevator 2: Platform 2 to the top of the crane (suites and spa pool deck)
- Elevator 1: Ground floor/Entrance to Studio & Platform 2
- Emergency stairs: (Only in case of emergency; From public toilets to the top)
- Without written permission from Faralda it is not allowed to use the elevator 2.
- It is strictly forbidden to use the emergency stairs.

**Suite(s):**

It is strictly forbidden to entre the tower, emergency stairs or the suites on top of the crane. Access to a suite is only allowed after written approval of Faralda. Faralda applies General Conditions and Manual.

**Cancellation Policy:**

- A booking is final after payment, allocation and agreement of these Conditions and Manual.
- Faralda Crane Hotel applies a non-refundable cancellation policy.
- Payment is due upon reservation.
- In case of cancellations, there will be no refunds/restitution.
- An alternative date is only available with the written consent of Faralda Crane Hotel.
- We apply our General Delivery and Payment Conditions and the Faralda Manual.
- A booking is personal and non-transferable.
- An offer is not valid in combination with other promotions.
- In all circumstances, Faralda reserves the right to cancel bookings and refuse requests.
- A booking and payment is non-transferable, non-exchangeable, non-refundable and non-reschedulable.
